Since April 2024 the following link visits have taken place;

Early Years Link Visit. Mr Neil Turner (NT) carried out his summer term Early Years link visit on 22.05.24 when he met with Ms G. Bennett (GB - Early Years Lead). They reviewed the Early Years Subject Leader Development Plan. GB updated progress on the: -

- development of the outside area and continuous provision to support meaningful play
- development of Maths in EYFS and ensure it is embedded in the environment to support engaging play
- development of assessments to show clear progression each term
- progress of pupils in vulnerable groups to make accelerated progress and narrow the gap between them and their

NT also observed Carpet Time (story time), a reading group and an active learning session.

**SEND Link Visit.** Mr Peter Falconbridge (PF) carried out his summer term SEND link visit on **04.06.24** when he met with Ms J. Fitzgerald (JF - Inclusion Officer). They reviewed:

Performance Management Link Visit. Mr Peter Falconbridge (PF) carried out his summer term Performance Management Link visit on 04.06.24 When he met with Mrs D. Marlow (DM) and Mrs J. Devonshire (JD). They reviewed the 2023-2024 Staff Appraisal cycle and the process for setting performance management targets. They also reviewed the spring 2024 Quality of Teaching and Learning profile (QTLP)

Vulnerable Groups Link Visit. Mr. Peter Falconbridge carried out his summer term Vulnerable Groups Link Visit on **04.06.24.** when he met with Mrs D. Marlow (DM) and Mrs J. Devonshire (JD). They discussed the impact of the 2020-2024 PPG and SPG Support Plans and arrangements for the 2024-2027 Support Plans, which will be confirmed in the autumn term 2024.

Christian Distinctiveness Link Visit. Mr. John Forrest carried out is summer term Christian Distinctiveness Link Visit on 20.06.24 when he visited Mrs T. Lines (RE Lead). They discussed the development of spirituality across the school, progress in the Archbishop's Young Leader's Award and the impact 'Understanding Christianity' and 'The Emmanuel Project on the RE Curriculum.

Health & Safety Link Visit. Mr J. Nicolson (JN) carried out his summer term Health & Safety Link Visit on **20.06.24** when he met with the Premises Management Team (PMT). The Buildings Maintenance Management Plan was reviewed to: -

- ensure actions are undertaken as swiftly as possible and recorded appropriately.
- Review and agree plans for future work.

Mathematics Link Visit. Mr Dale Webster (DLW) carried out his summer Mathematics Link Visit on 18.07.24 when he met with Mr D. Fitch (DF – Maths Lead) and Mrs D. Marlowe (DM). They discussed the 2024 End of Year Results for mathematics and appropriate plans to address areas for improvement, including the introduction of the White Rose Maths system and NfER assessment testing.

Safeguarding Link Visit. Mrs Cathy Irons carried out two summer term Safeguarding Link Visits, on 17.07.24 and 24.07.24, when she visited Mrs J. Fitzgerald (JF - Safeguarding Lead) and Mrs T. Fisher (TF - School Business Manager). She was accompanied by Mr Thomas Dowle (TF), who will be taking over as Safeguarding Link Governor from September 2024. At the meeting on 17.07.24 the summer term Safeguarding Report was completed. This will be published to governors ahead of the Autumn 2024 FGB Meeting. Governors also discussed environmental sustainability and the impact of social media on pupil behaviour. The 2020-2024 Equality Objectives and update for the Summer 2024 was discussed. The new 2024-2027 Equality Objectives were agreed. There was a discussion about the outstanding work required to complete the Music Suite Project.
